

TERMS AND CONDITIONS

Definitions:

The "Company" refers to Globalized Nations Ltd

The "Client" means the party with whom this Agreement is drawn for the purpose of promotion within the Service.

The "Service" refers to the Globalized Nations website.

The "Business Region" refers to the geographic location as defined by the Company.
